



船舶入级业务 Ship Classification Services

入级包括制定独立的船用技术标准，以及在整个船舶寿命期间检验此类标准的适用性。ClassNU提供的船舶入级业务广为全球范围内船东、船旗国、保赔协会以及保险商认可。ClassNU稳步的发展主要归功于我们对实际情况的了解以及对海上安全和环保始终如一的严格要求。

同时，ClassNU规则制定流程还根据后果的严重性，使用了各种风险评估的方法。研发活动、业内经验反馈以及先进技术同样对规则制定流程有着重要意义。规则制定流程中采用的综合调控，确保了ClassNU的入级规则在技术方面不断更新。

The Classification concept comprises the development of independent marine technical standards for ships and the verification of compliance with these standards throughout the ship's life. ClassNU provide services on Ship Classification within the scope of the global Ship owners, Flag State, P&I Clubs and Underwriters recognition. ClassNU has achieved steady growth mainly due to our understanding of actual situations and the uncompromising approach to maritime safety and environment protection.

We formulate rules aims to ensure a high degree of safety and preventive measures on harm to shipping process personnel, passengers, ships, goods and the environment. The Rules and Regulations for Classification of ClassNU are a result of vast technical expertise of the Classification Society and are perfected through a rigorous process of approval by multi-level committees comprising of experts in the shipping industry from various technical fields and sectors such as flag states, port states, ship owners / operators, insurer, P&I Clubs and auxiliary industries.

At the same time, ClassNU's rule-making process also based on various risk assessment methodologies depending on the severity of the consequences. The R&D activities, industry experience feedback and advanced technology also contribute significantly to the rule-making process. Comprehensive controls applied in the rule-making process ensure that the Classification rules of ClassNU are up-to-date with respect to technology and unbiased with respect to its content.

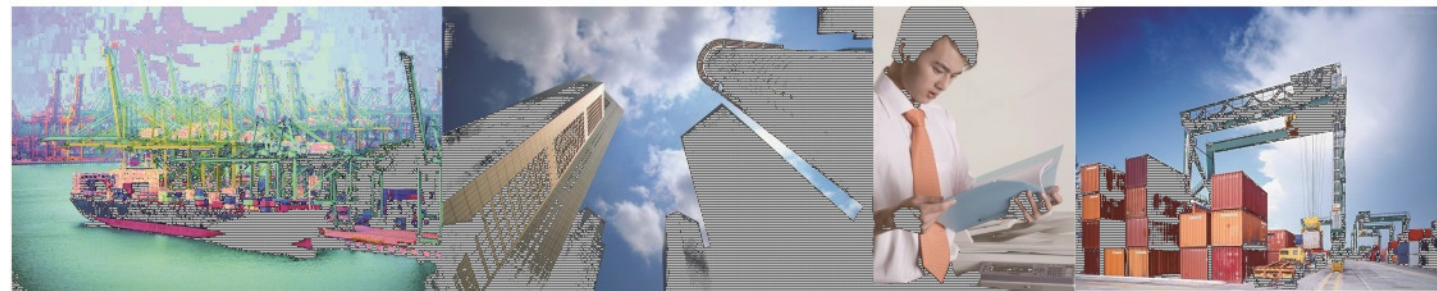
ClassNU is duly authorized by several countries to perform ship surveys, audits and plan appraisals according to international conventions, codes and national regulations to issue ship certificates.

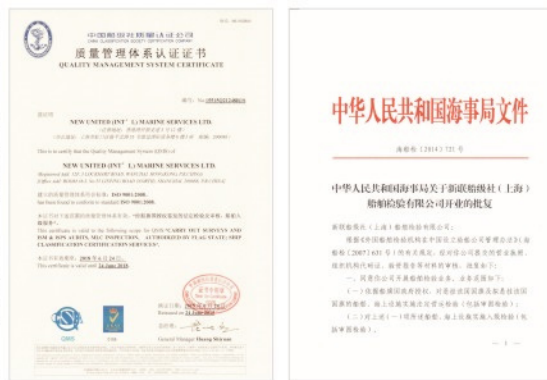
